

City of Tampa Post-Disaster Redevelopment Plan Survey Results

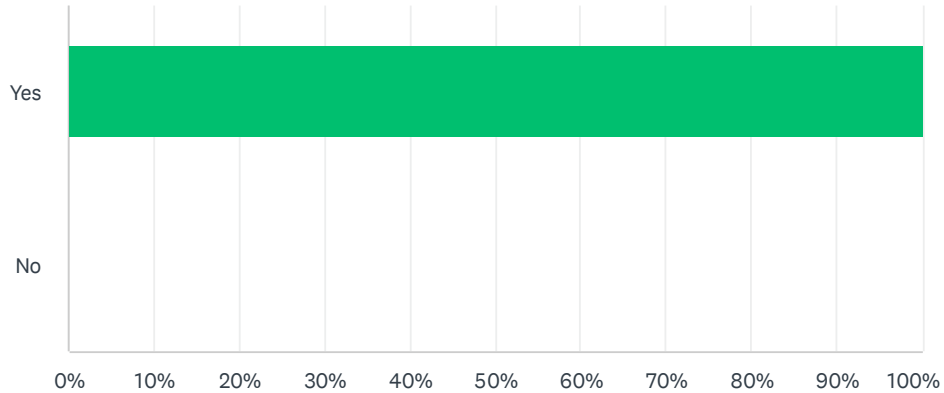
A public survey was designed to gather input from the entire Tampa Bay region. To broaden participation, the online survey remained open for several months following the first public workshop and was promoted via the City's website and partner channels.

The survey included 35 questions that asked residents about their recent experiences with disaster recovery, priorities for redevelopment, and perspectives on resilience strategies such as housing, infrastructure, and environmental protection.

Across the Tampa Bay Region, which includes Hillsborough, Pinellas, and Hernando counties, 473 individuals completed the survey. Of those, 87 respondents identified as City of Tampa residents. Their responses provide insight into the lived experiences and priorities of the City's populations. All survey responses for the City of Tampa are available below.

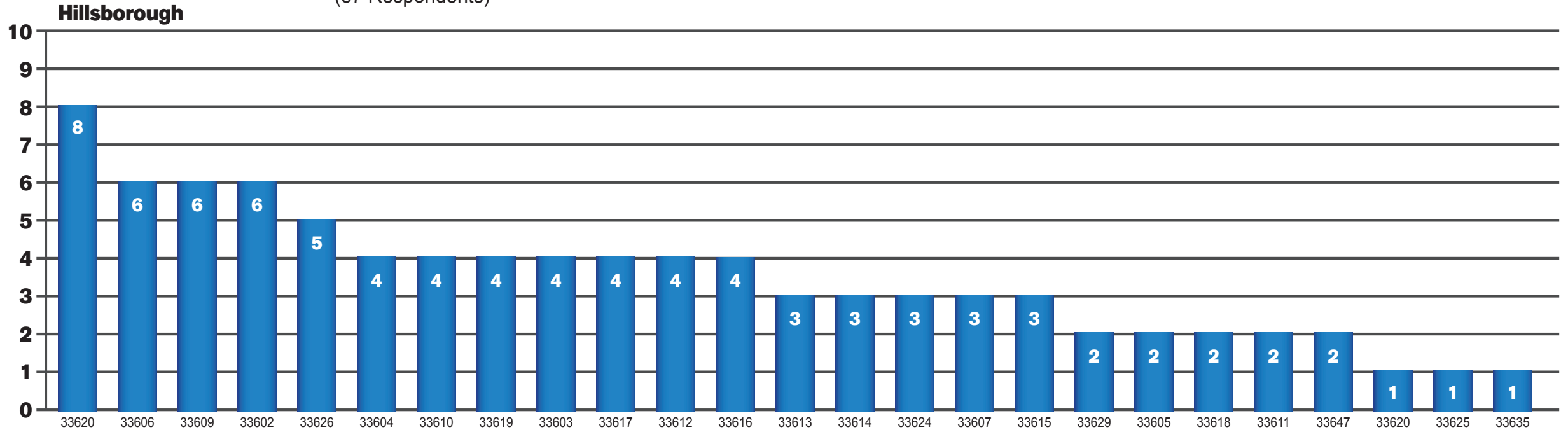

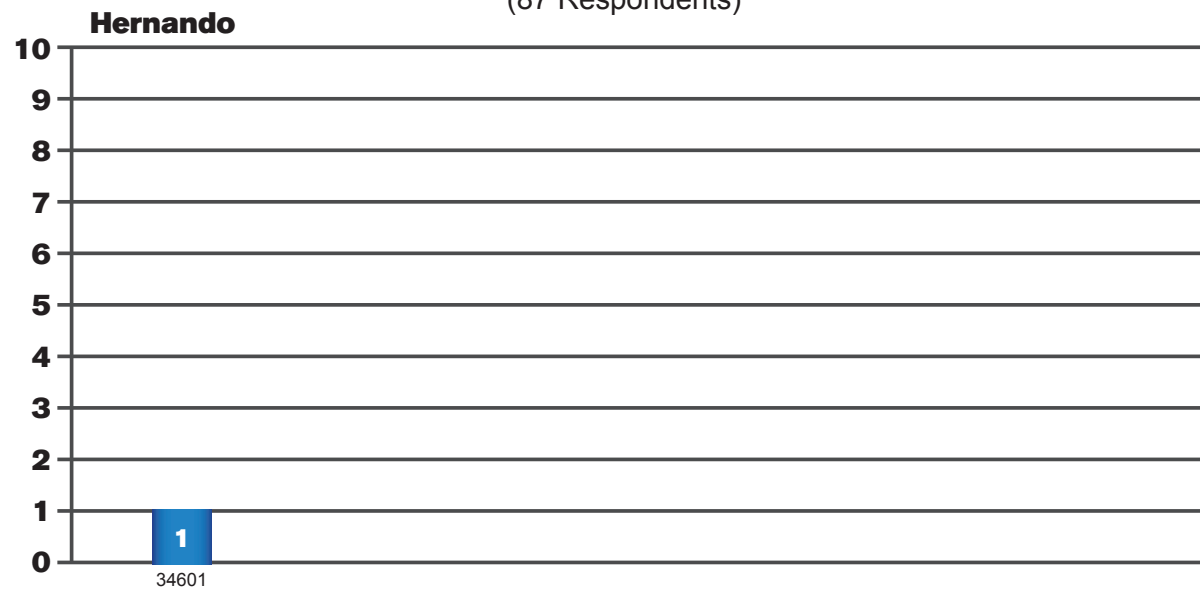
**Is your primary residence in Hillsborough, Pinellas, or Hernando?

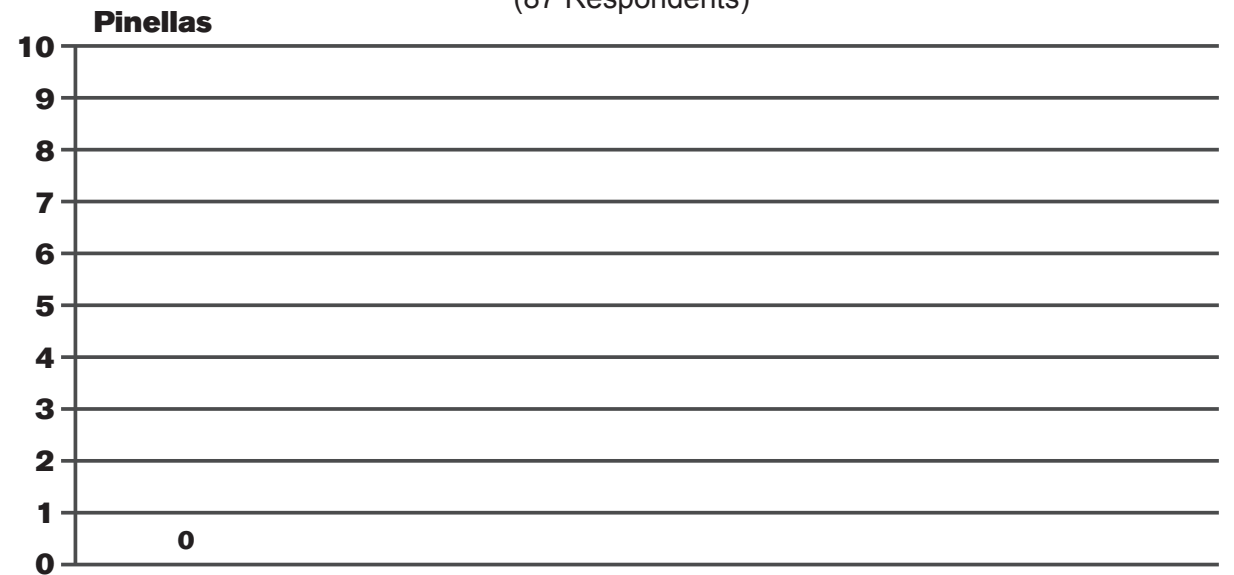

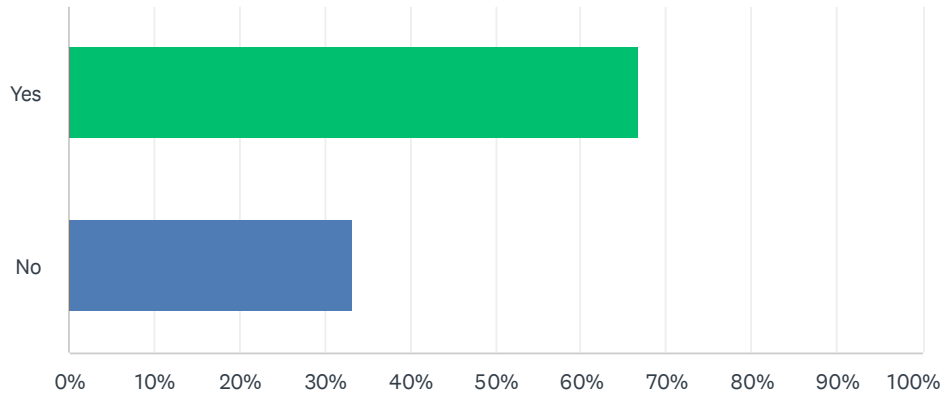

Q3 Has your home been affected by a natural disaster in the past?

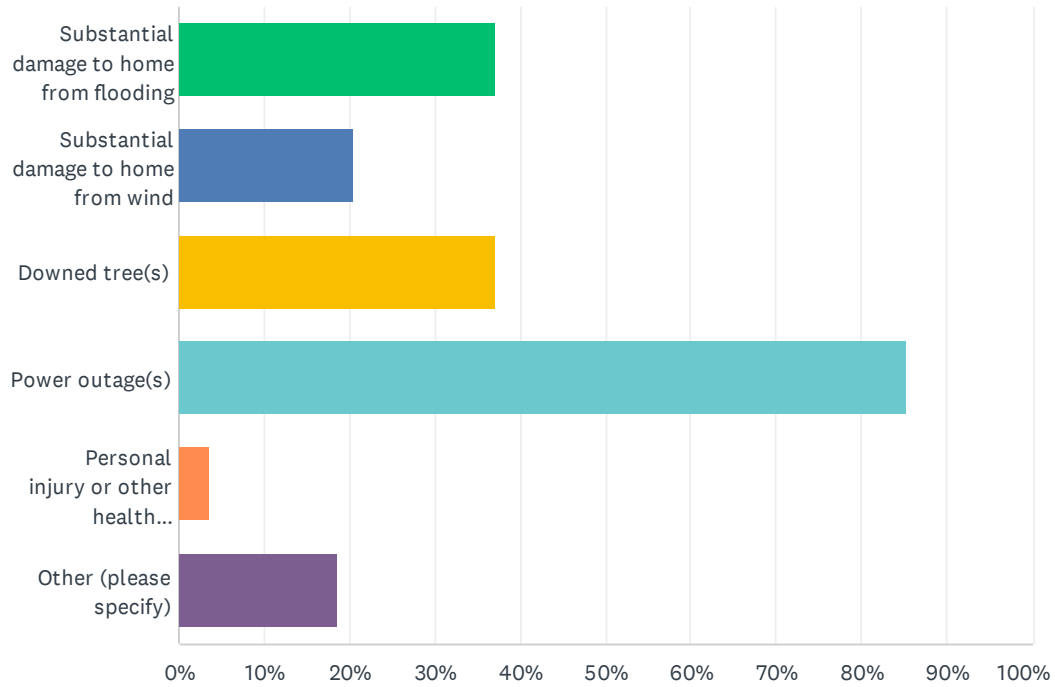

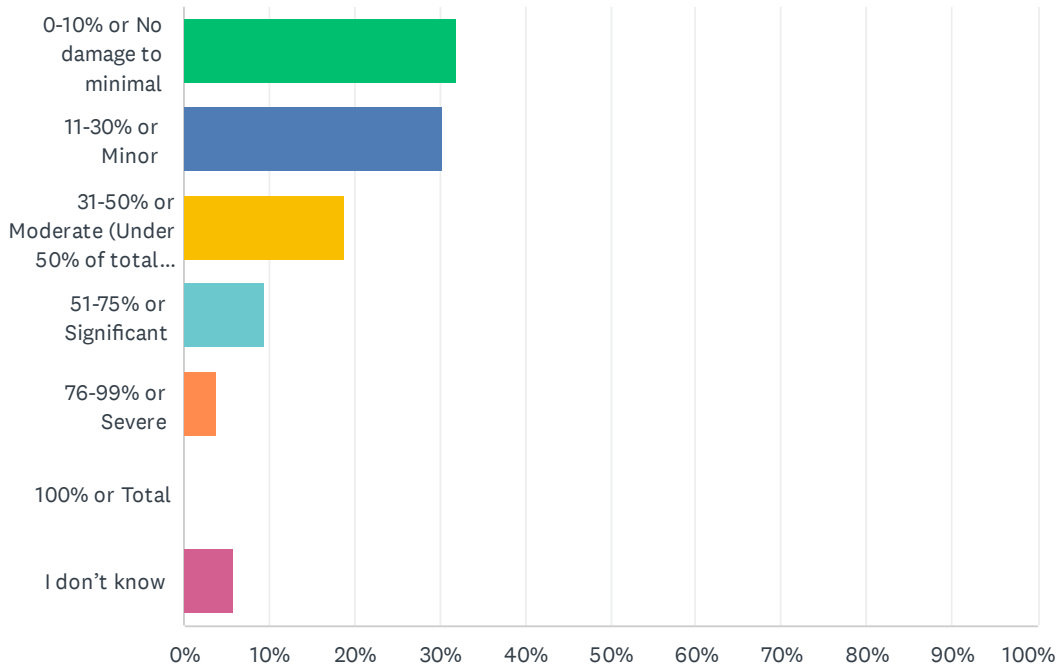

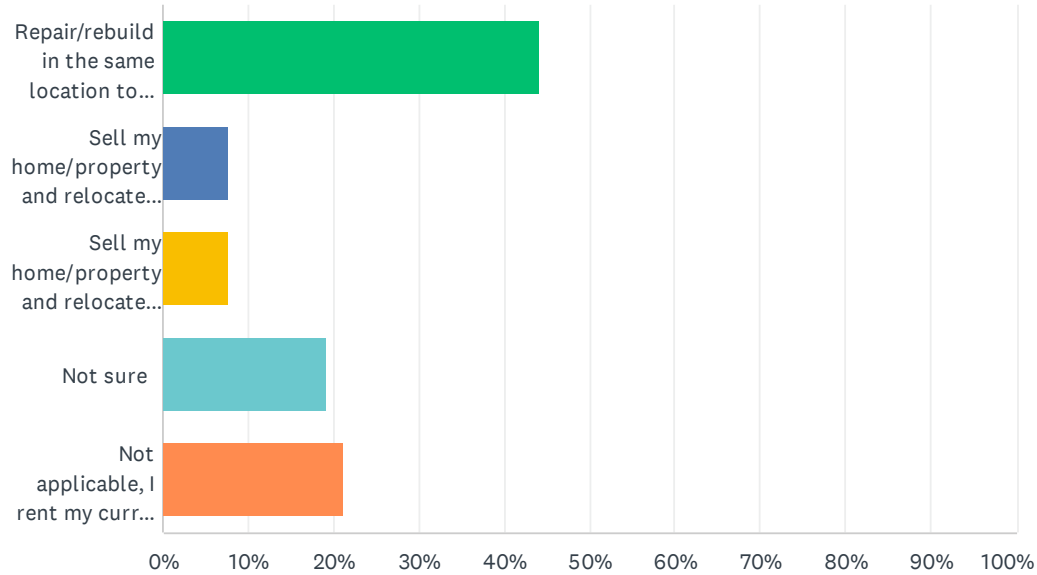

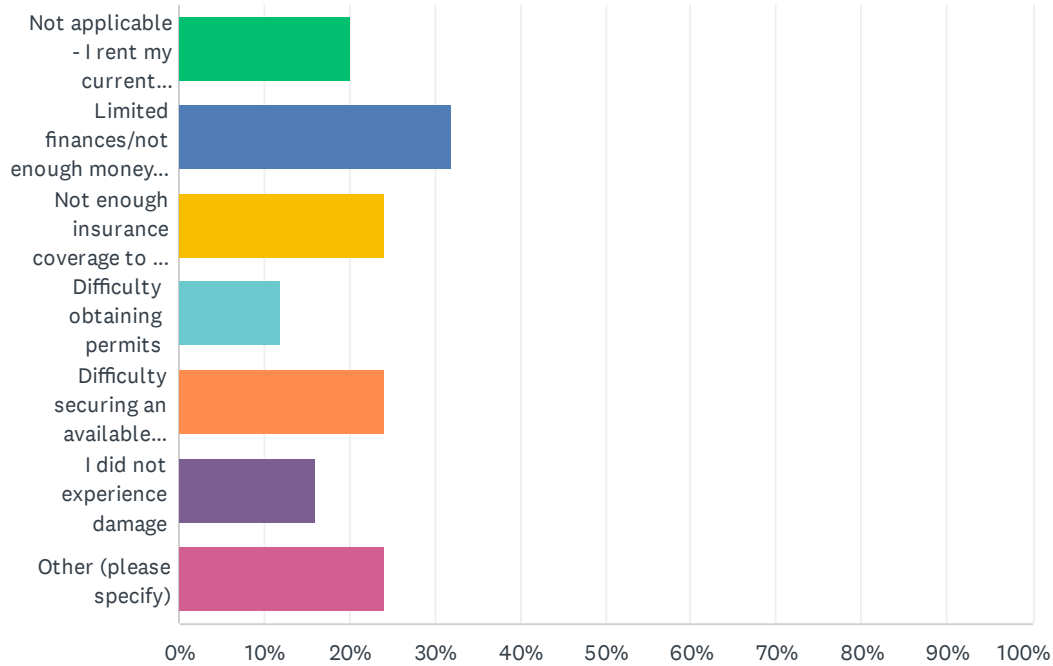

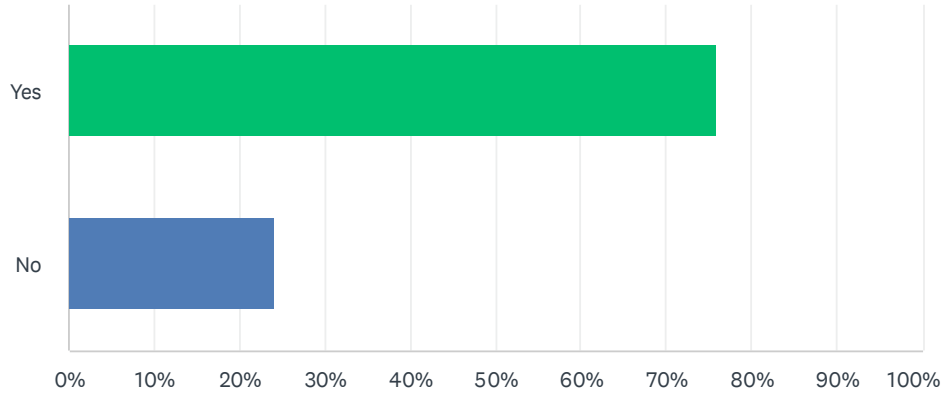

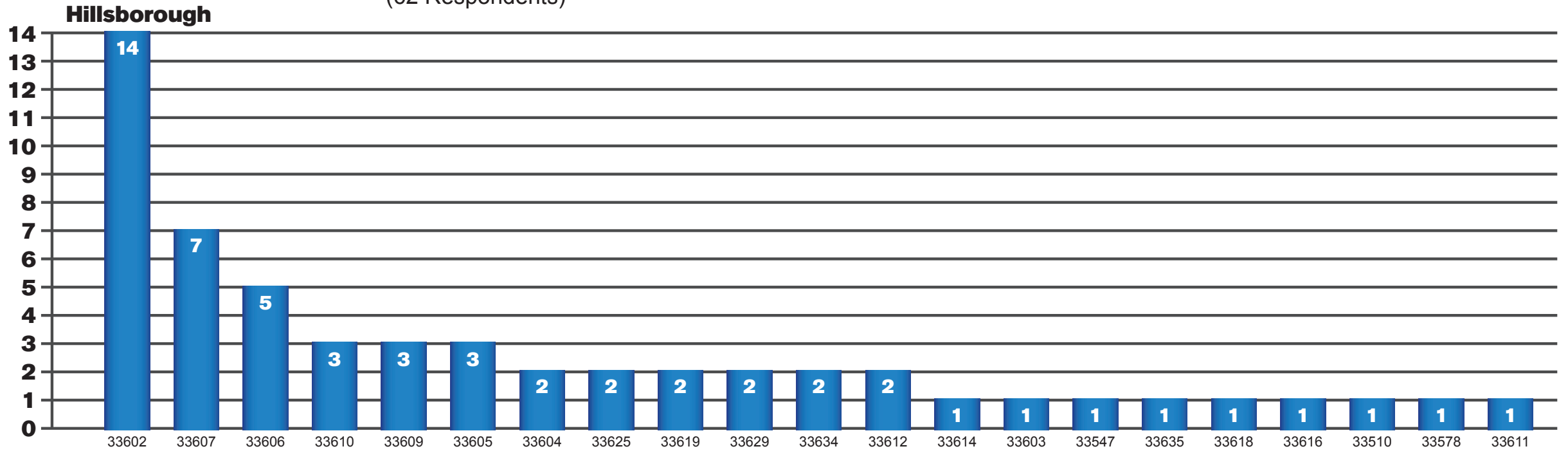

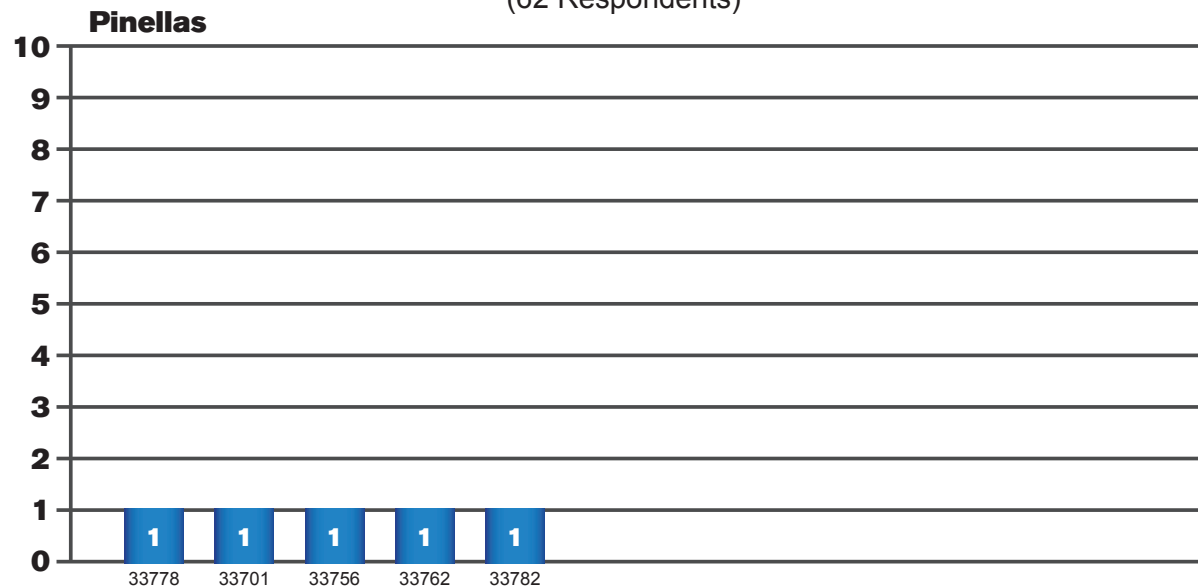

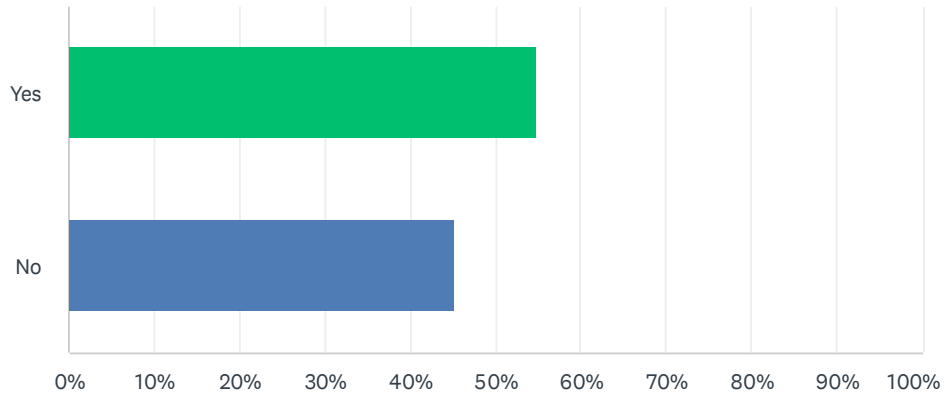

Q10 Has your work location been affected by a disaster in the past?

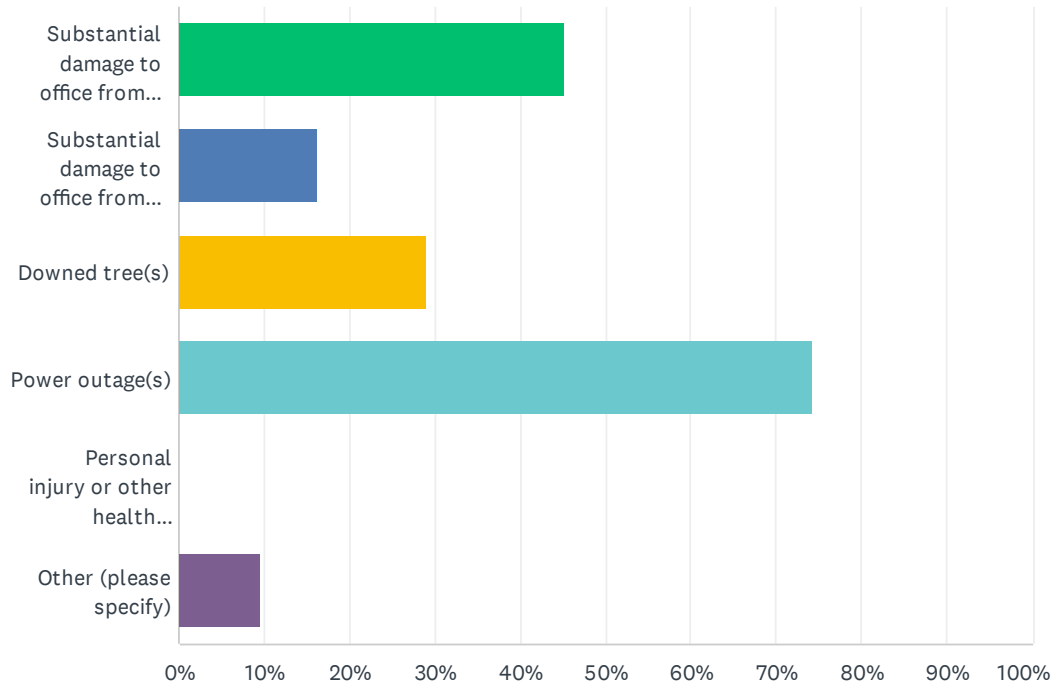

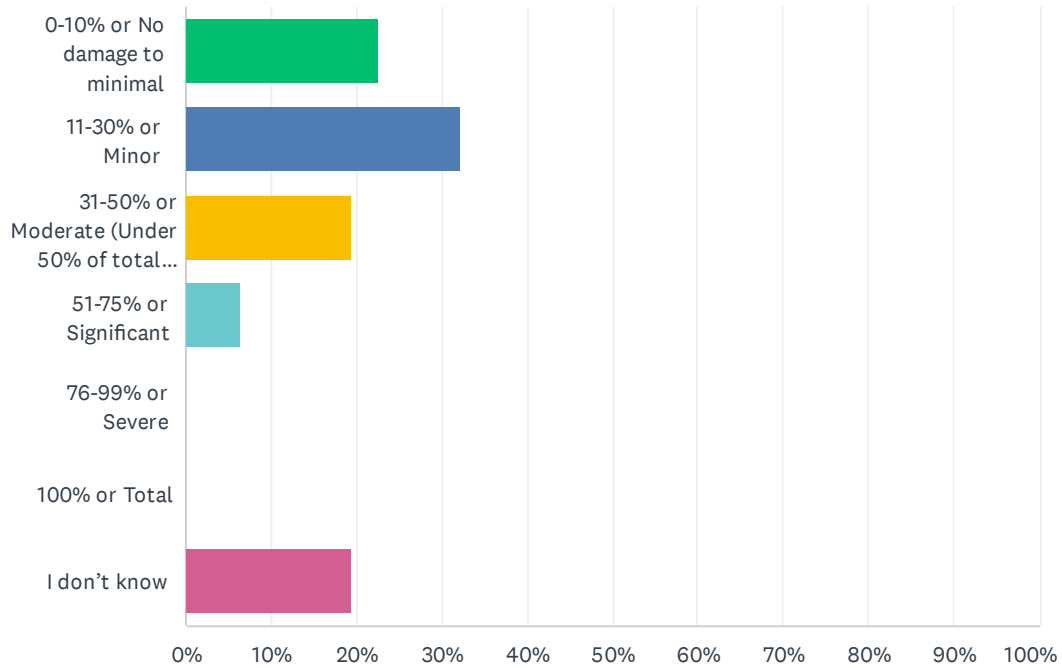

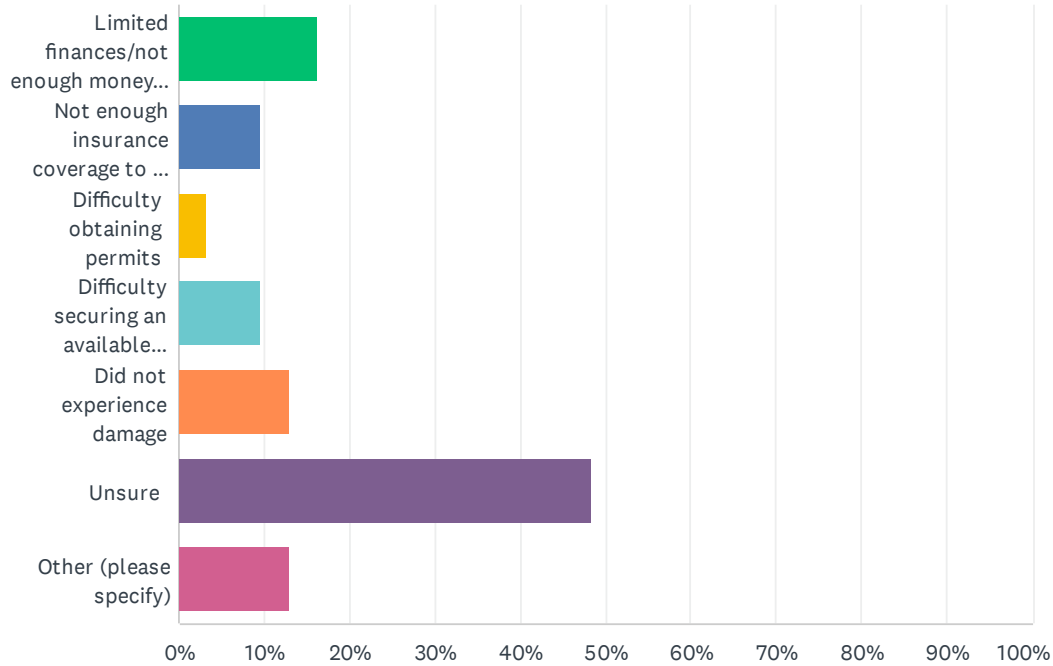

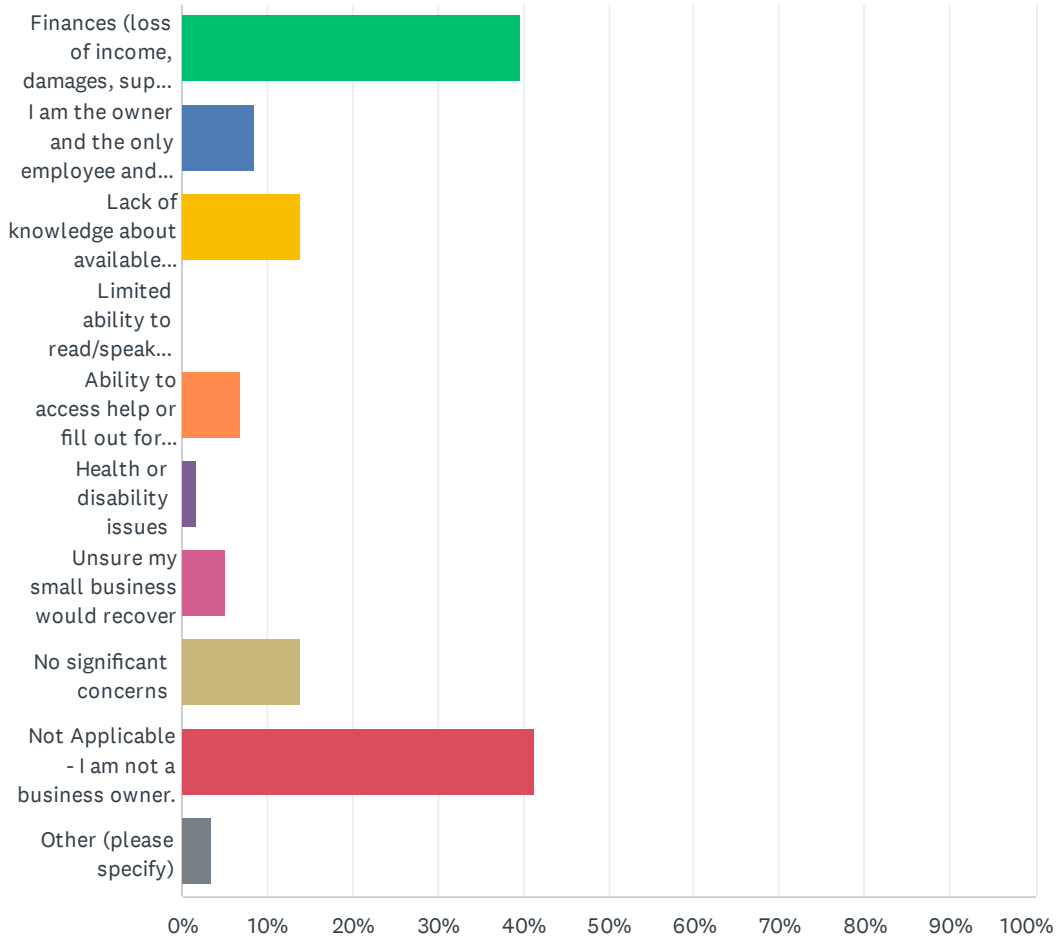

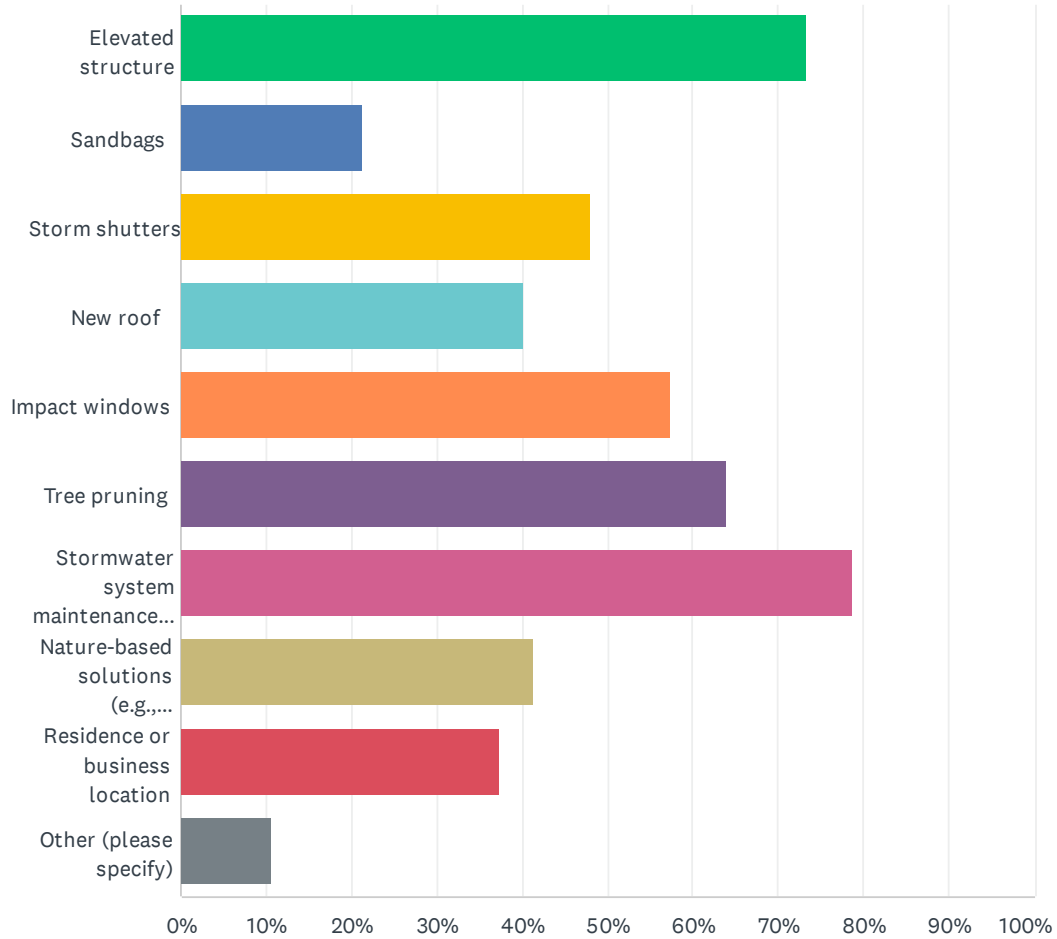

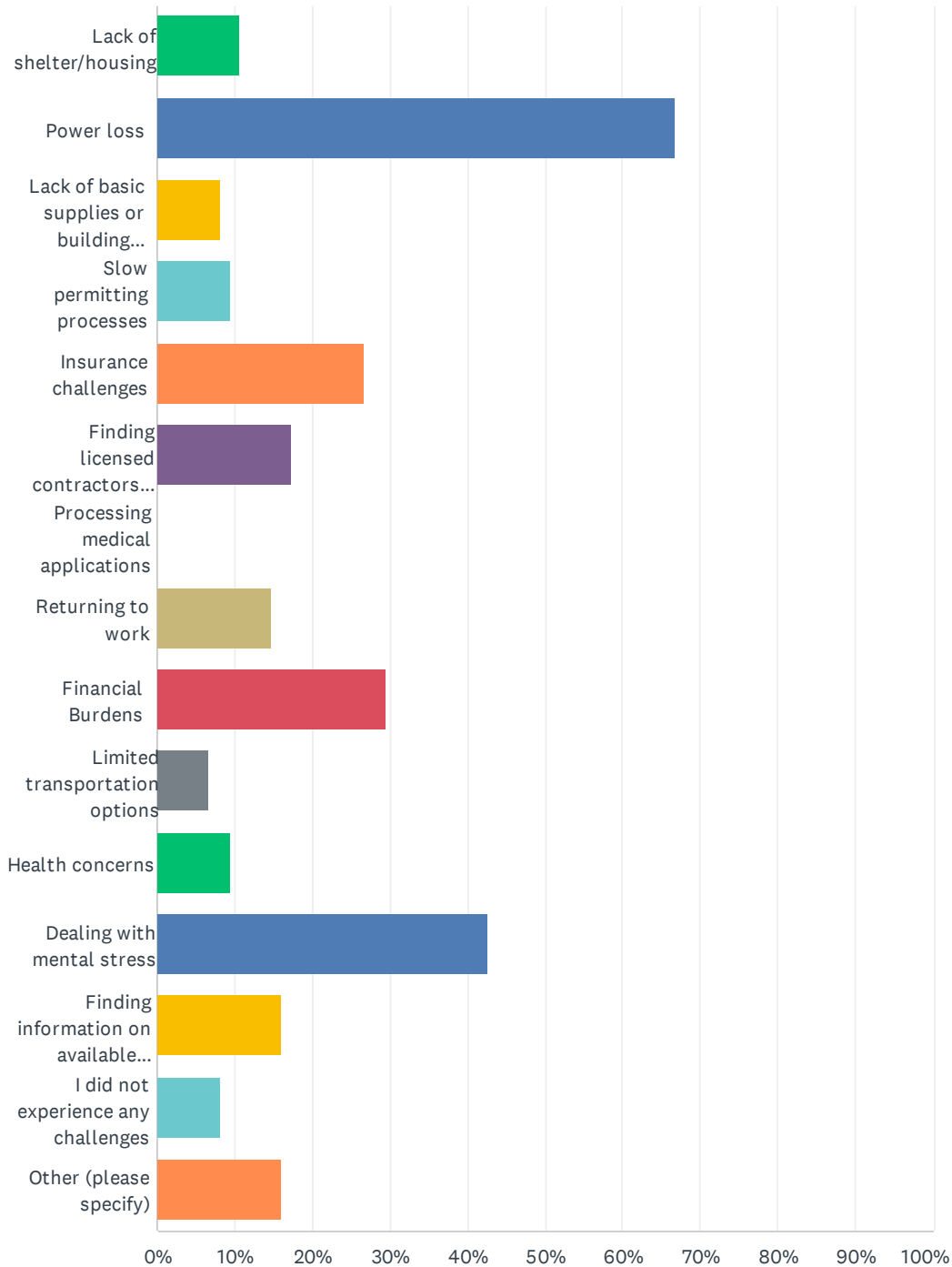

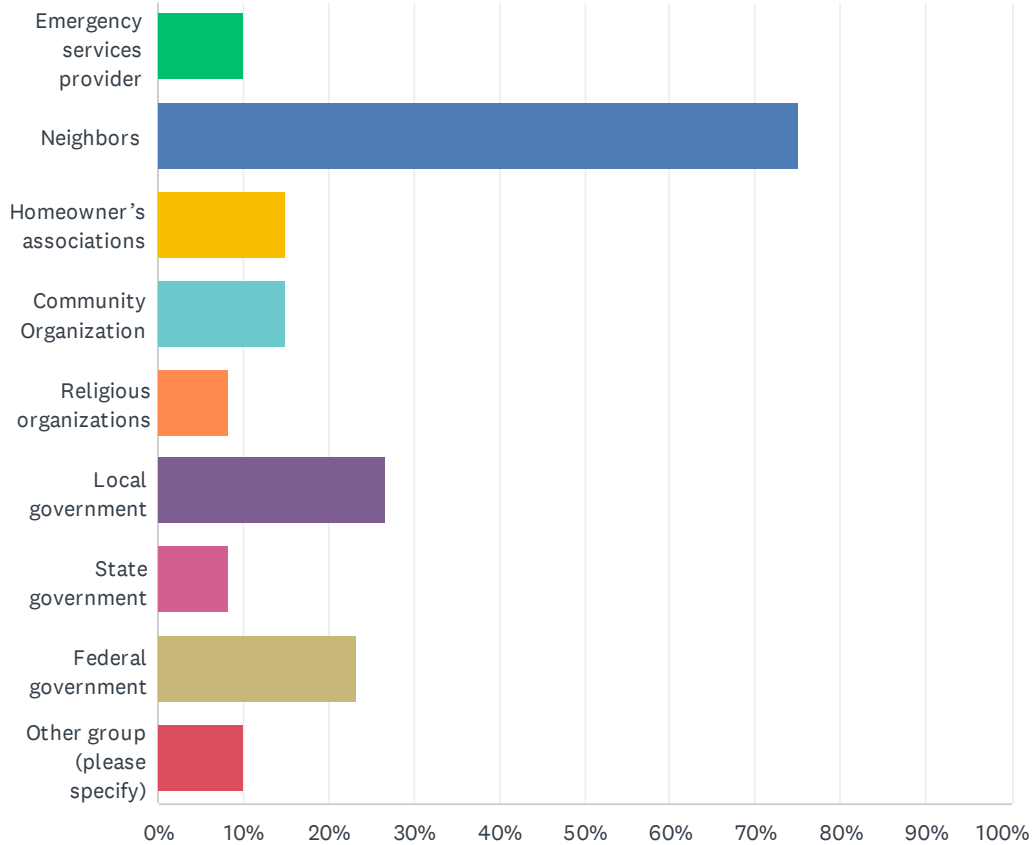

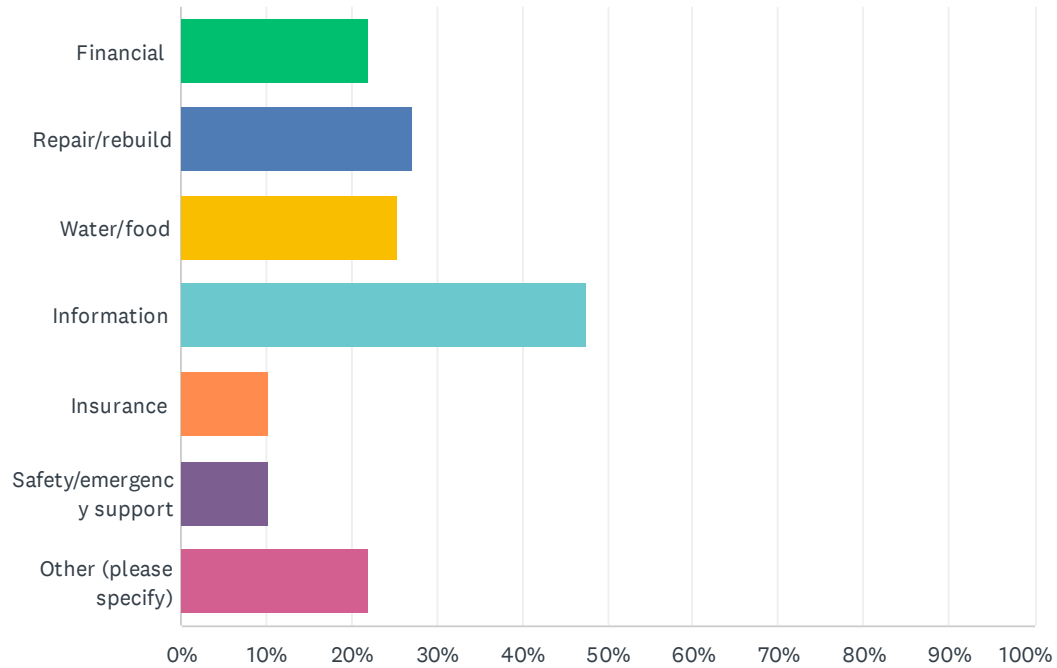

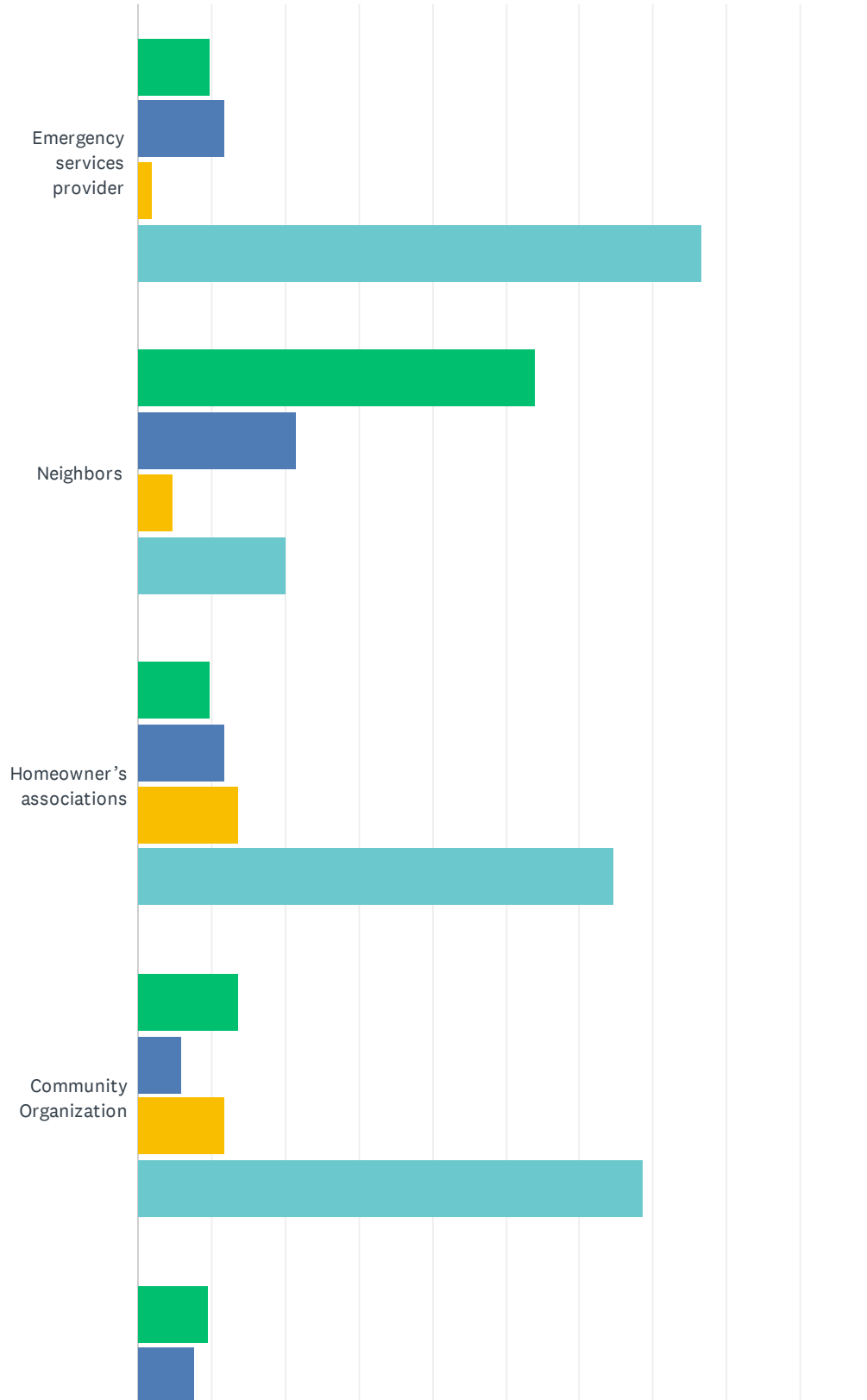

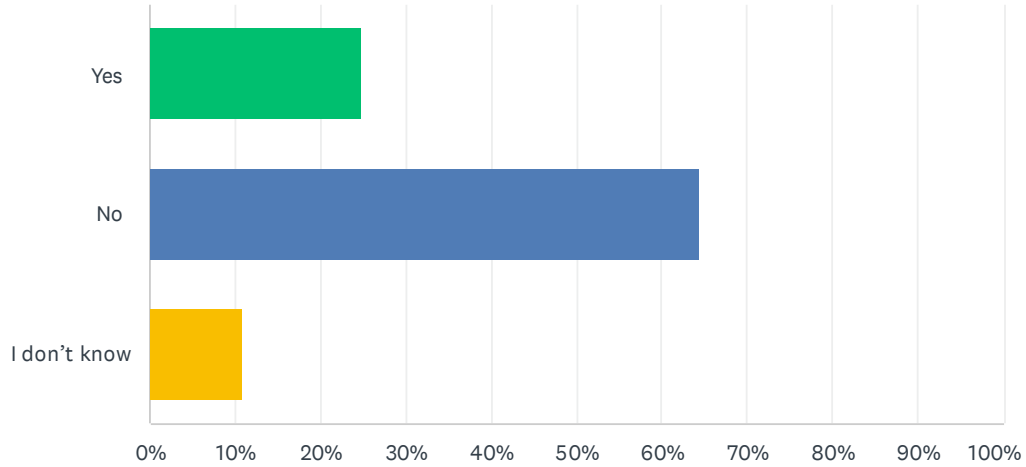

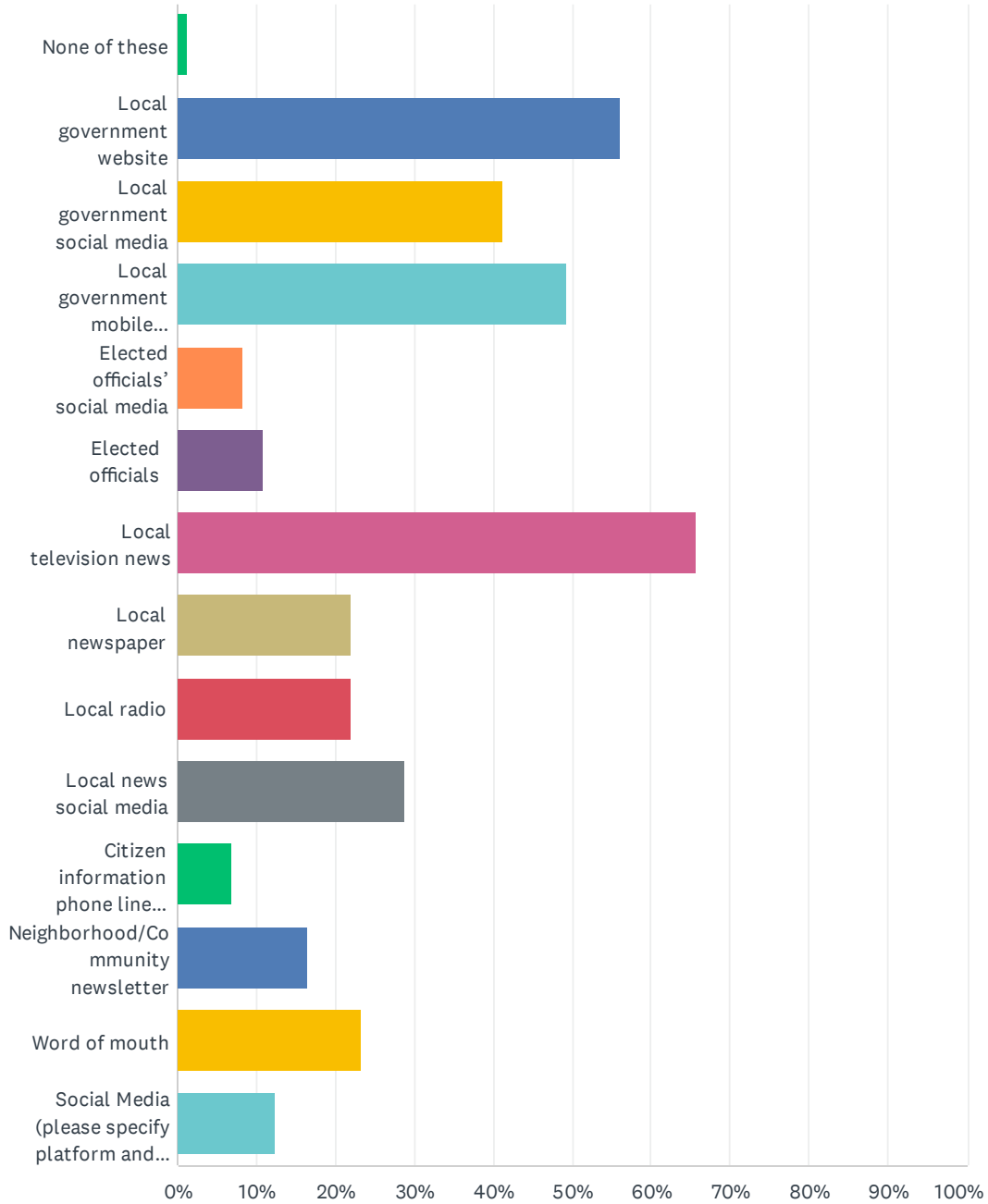

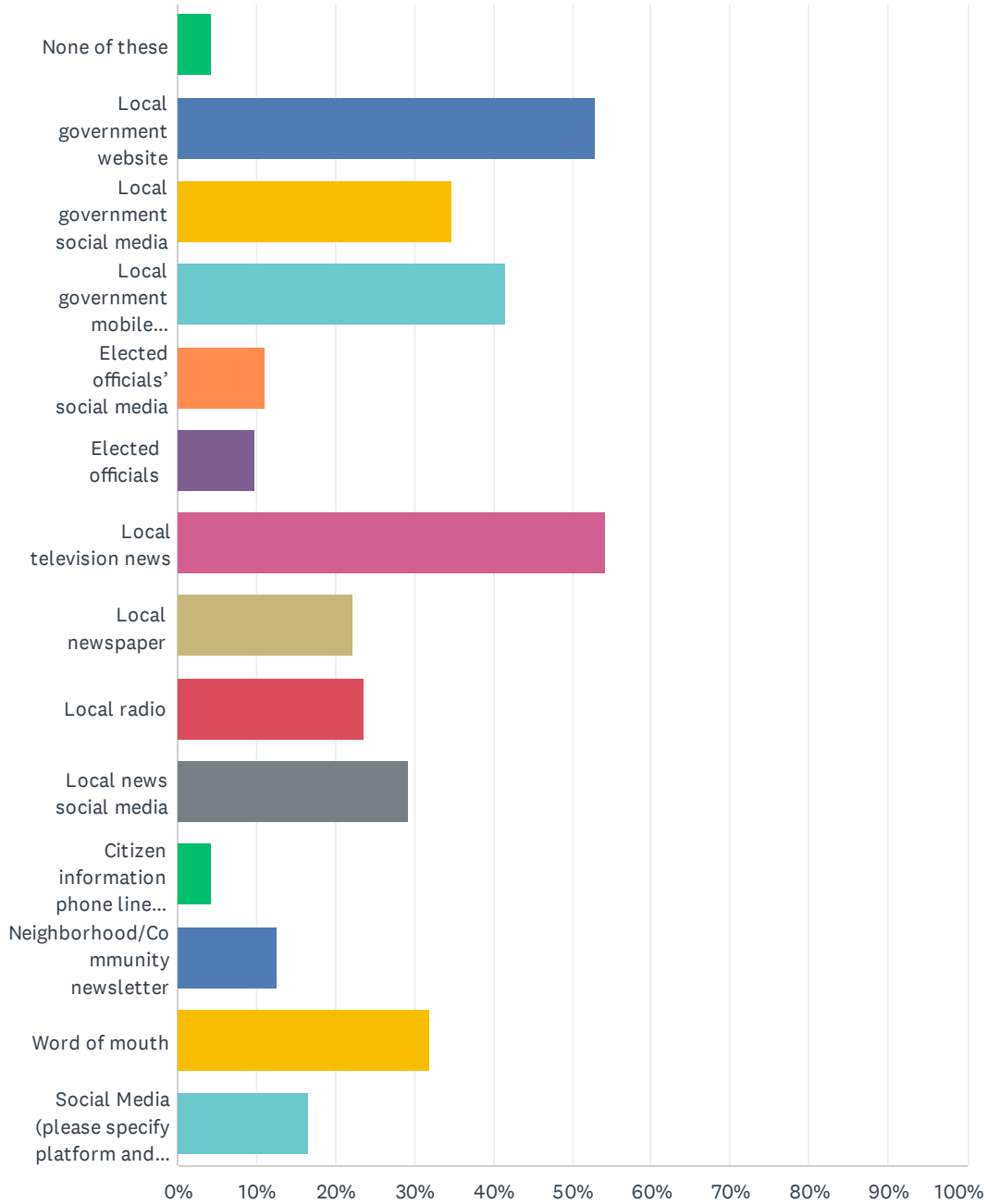

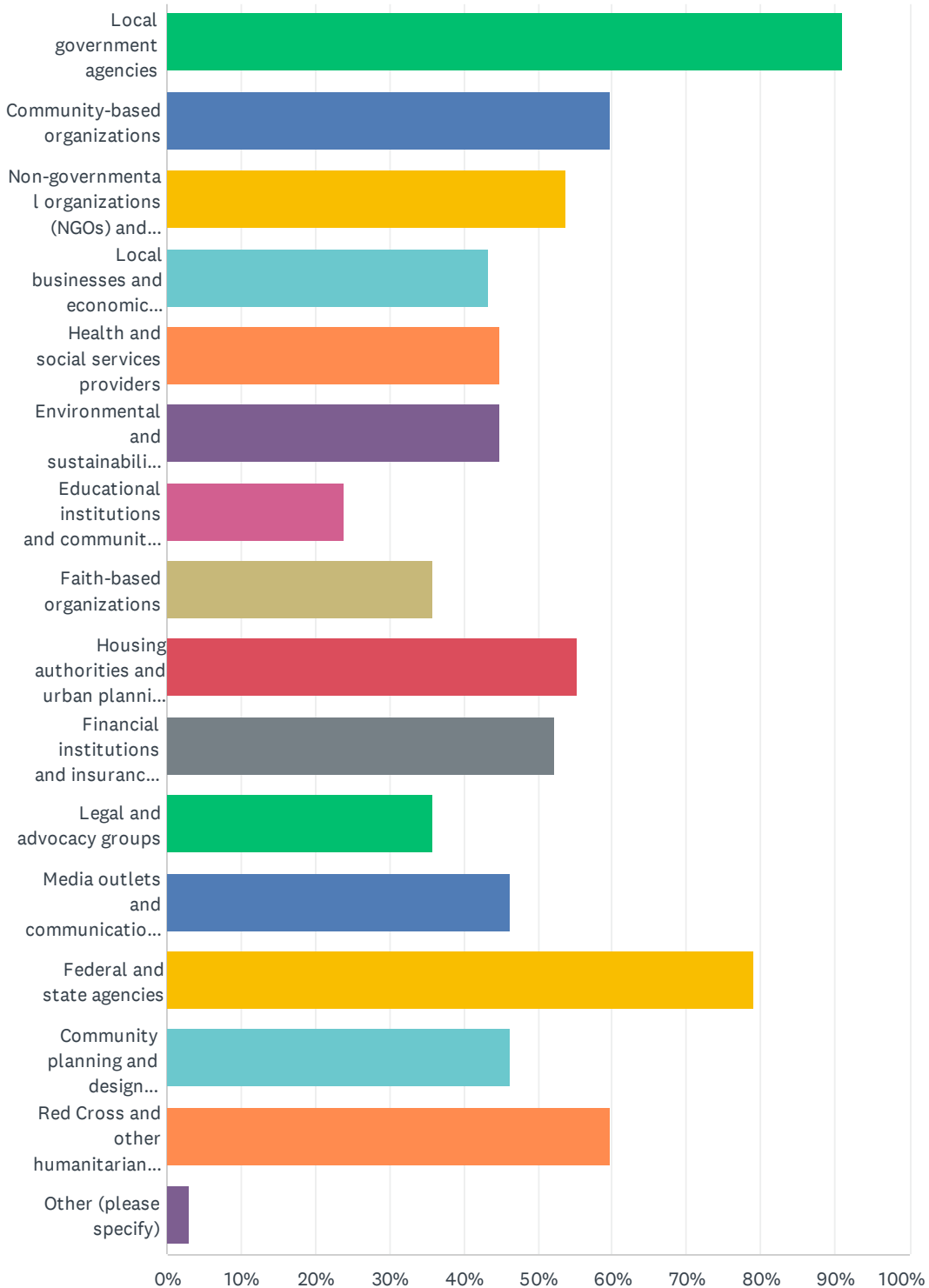

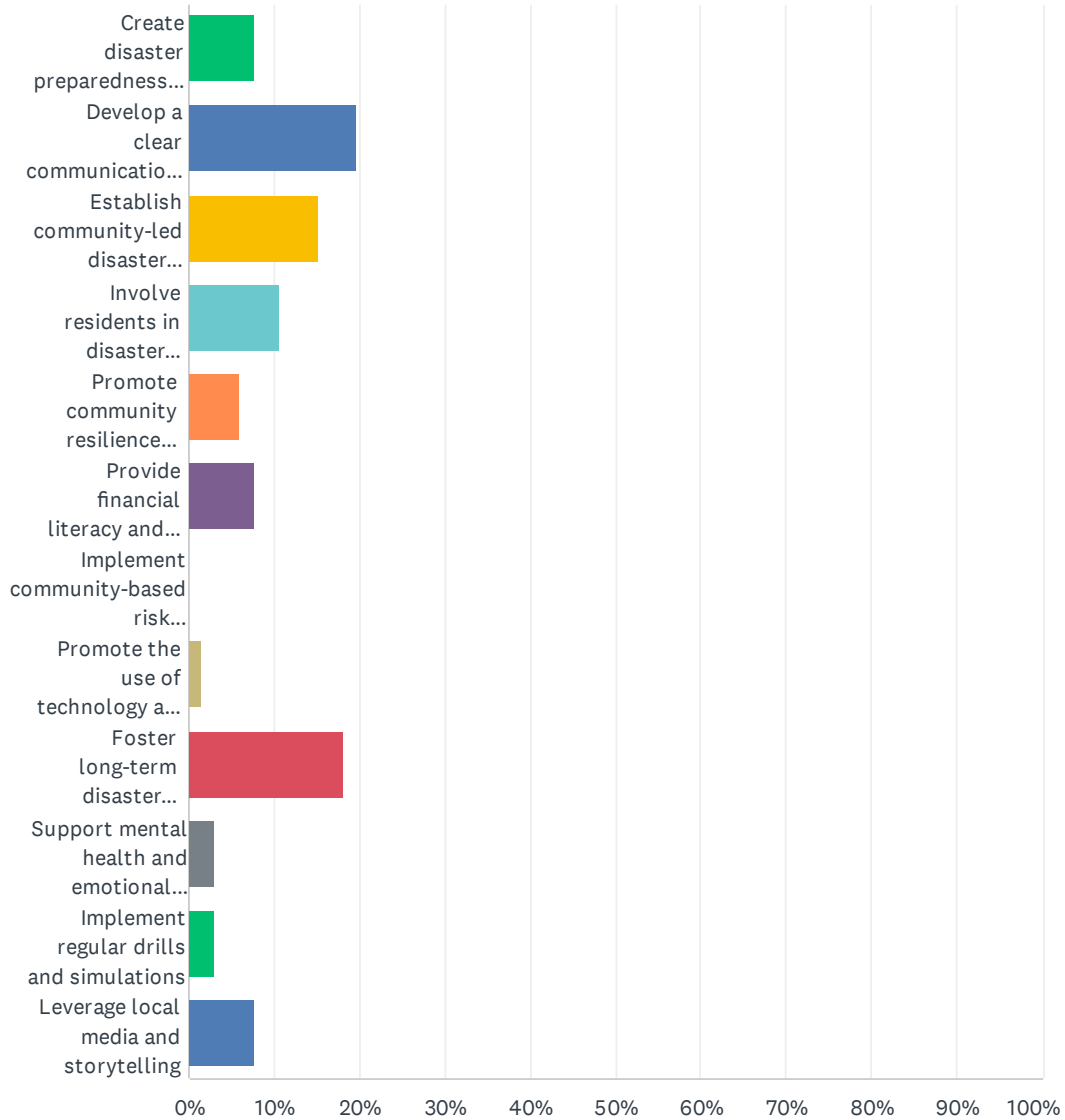

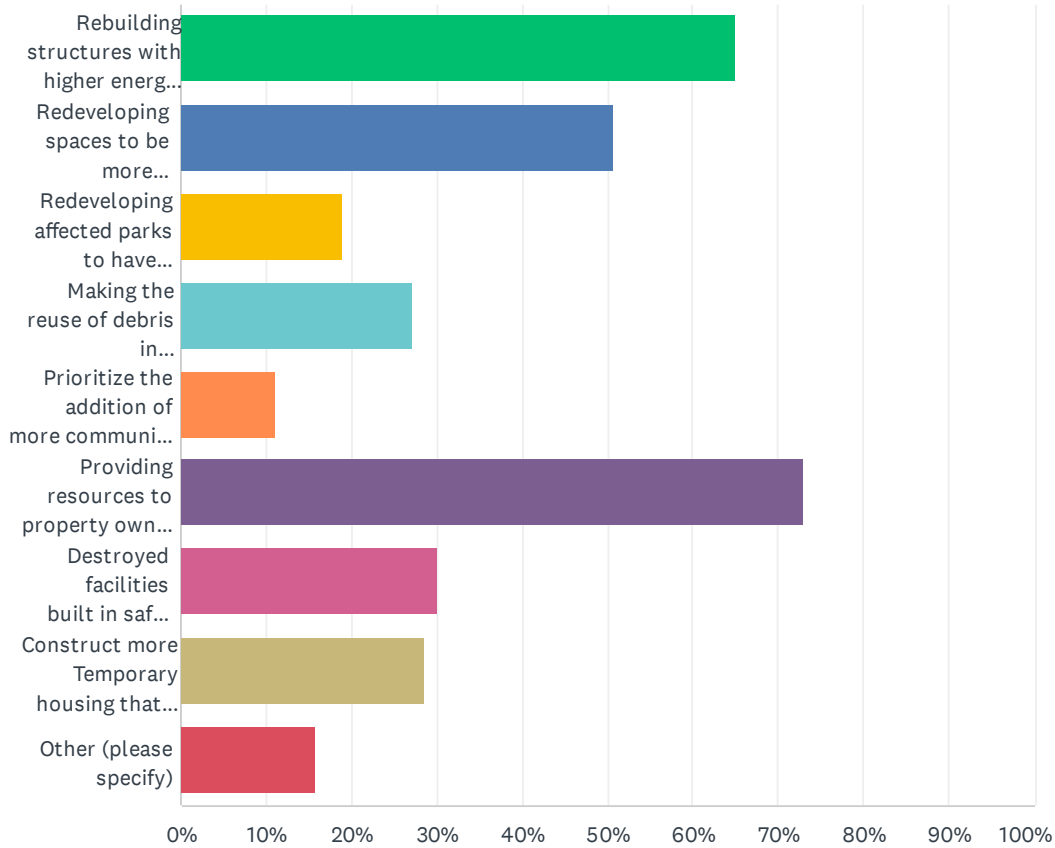

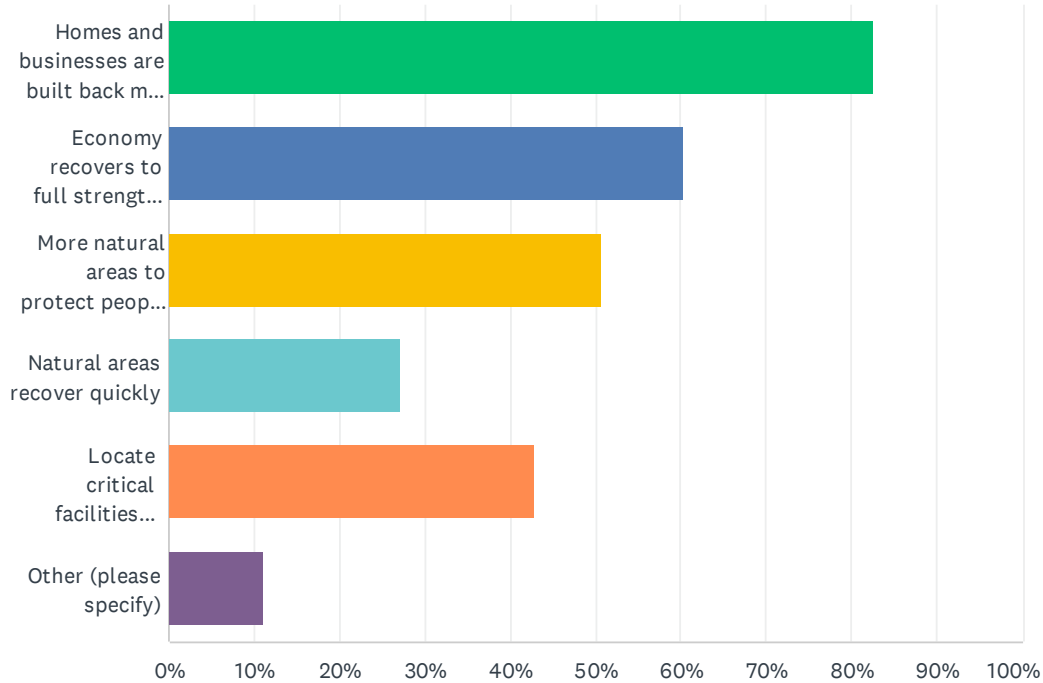

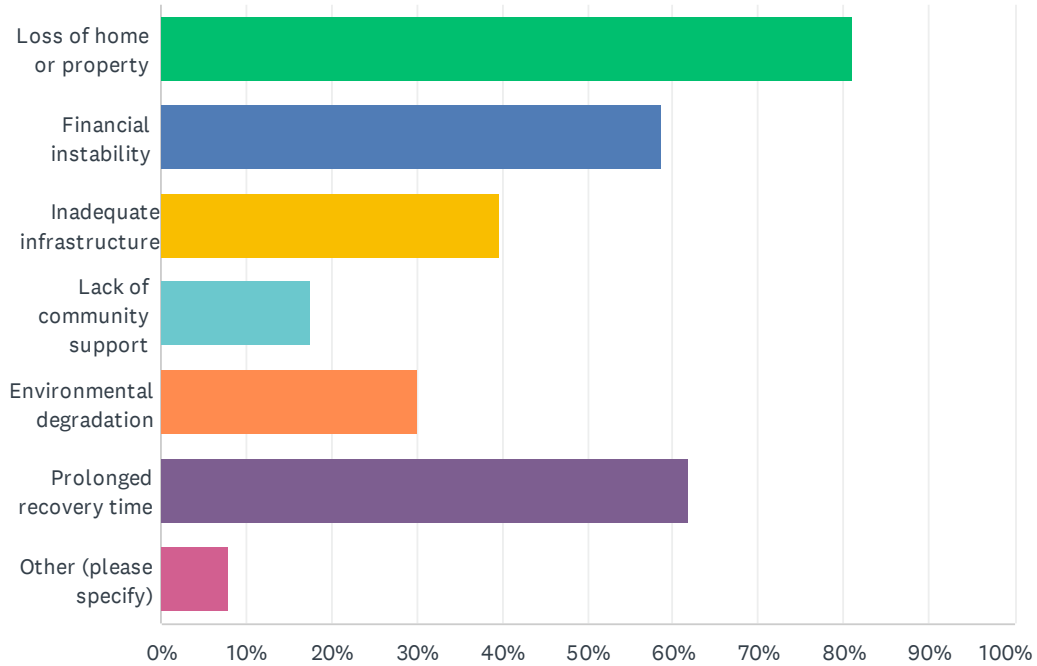

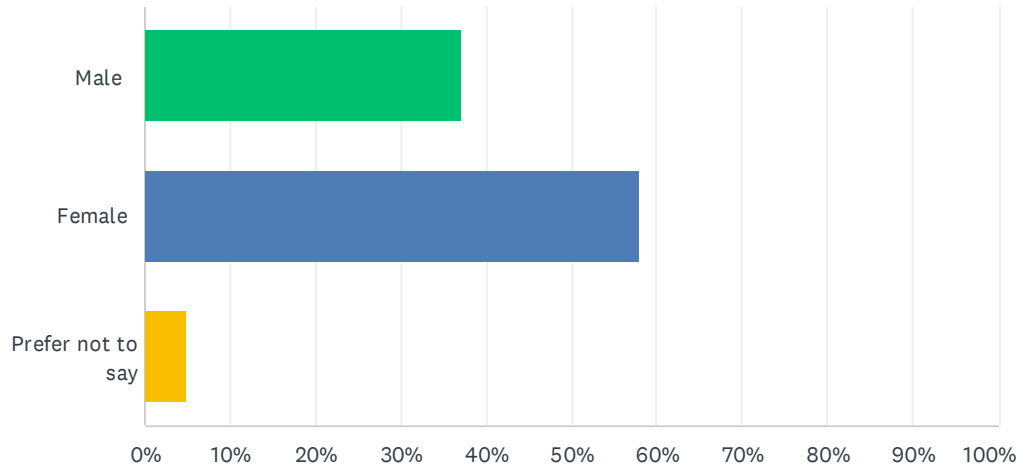

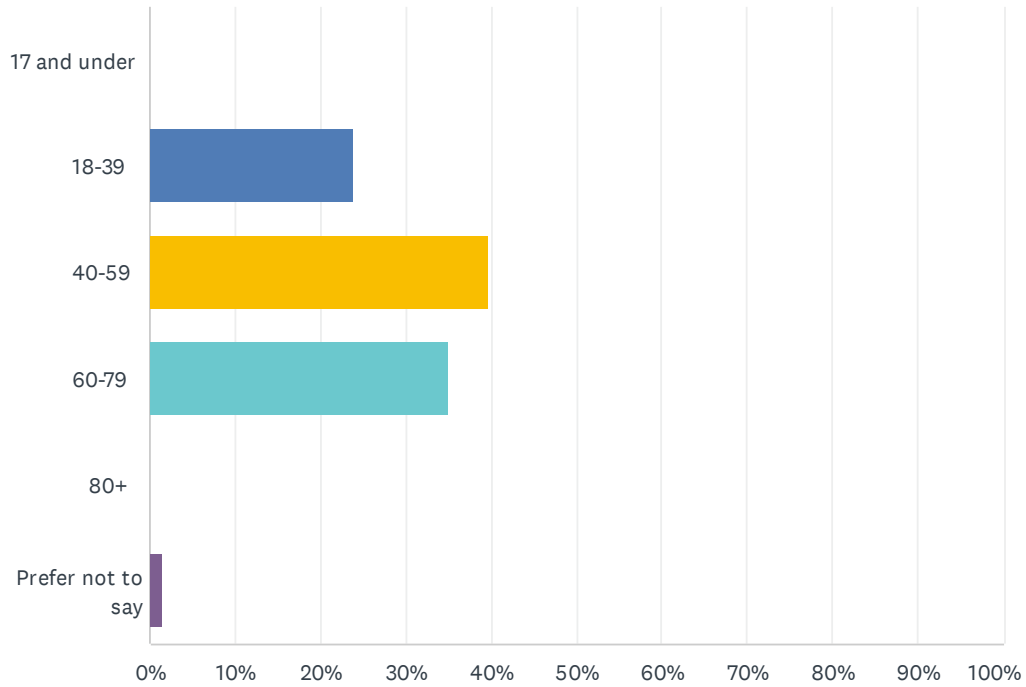

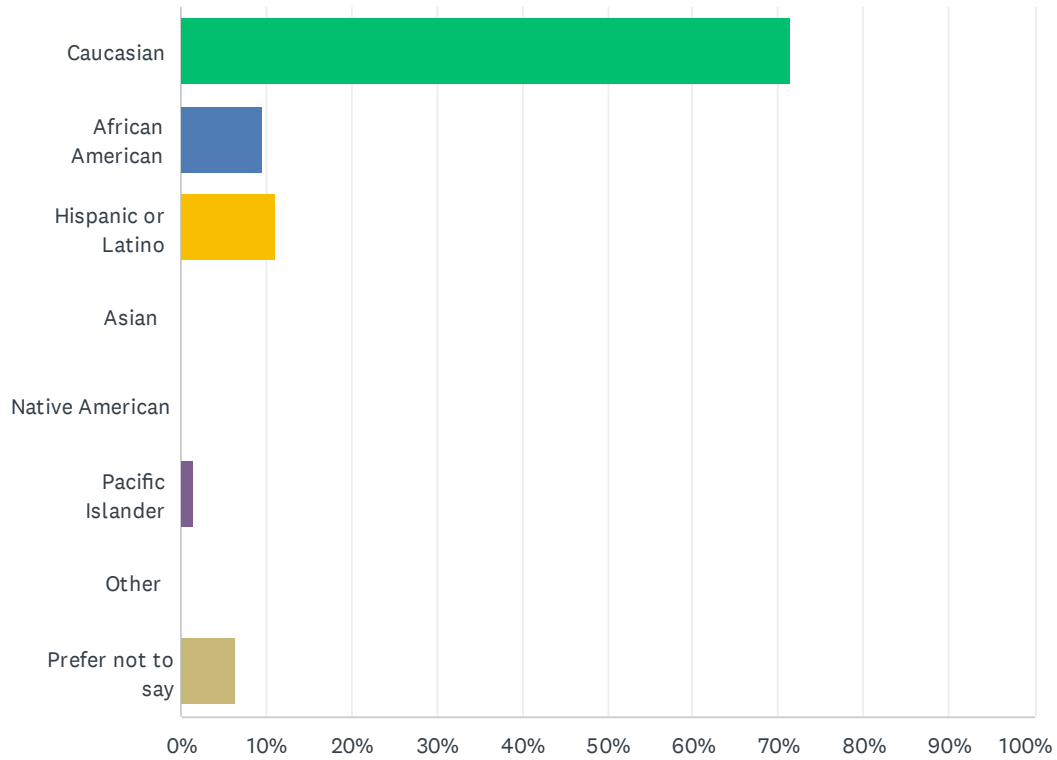
